Ambassador Madi represented Egypt at several meetings of the Commission on Human Rights. He played an instrumental role in establishing Egypt's National Council for Human Rights, and oversaw matters pertaining to the implementation of Egypt's international human rights obligations, including in the field of the rights of the child. Egypt was among the first countries to ratify the Convention on the Rights of the Child, and witnessed a

number of significant developments, including the ratification of the two Optional Protocols on involvement of children in armed conflict, and sale of children, child prostitution and child pornography, as well as the ILO Convention No. 182 on the Worst Forms of Child Labour. He also contributed to the launching of a national campaign to amend the 1996 Child Law, which culminated in the approval by parliament, in 2008, of a large number of important legislative amendments, including criminalization of female genital mutilation and raising the minimum marriage age for girls. In his capacity as Deputy Assistant Foreign Minister for Human Rights, Social and Humanitarian Affairs, he acted as the national coordinator of the relevant governmental departments in the field of human rights, where he initiated and formulated policies and strategies on human rights-related issues.
